**Specificity:** This assay has high sensitivity and excellent specificity for detection of Human D2D. No significant cross-reactivity or interference between Human D2D and analogues was observed.

## KIT Components & Storage

Store the kit at 4°C for 1 week. If the kit is not used up in 1 week, store the items separately according to the following conditions after the kit is received.

## Special Explanation

1. Please store kit at 4°C if used up in 1 week. If used for more than 1 week, store the Pre-Coated Microplate, Standard, Biotinylated Antibody and Streptavidin–HRP at –20°C and all other reagents at 4°C according to the temperature indicated on the label. Avoid repeated freeze–thaw cycles.
2. Do not use the kit beyond the expiration date.
3. After opening the package, please check that all components are complete.
4. The cap must be tightened to prevent evaporation and microbial contamination. The reagents volume is slightly more than the volume marked on labels, please use accurate measuring equipment and do not pour directly into the vial.

All kit components have been formulated and quality control tested to function successfully. Do not mix or substitute reagents or materials from other kits, detection effect of the kit will not be guaranteed if utilized separately or substituted.

## Materials Required, Not Supplied

1. Microplate reader capable of measuring absorbance at  $450 \pm 10$  nm.
2. High–speed centrifuge.
3. Electro–heating standing–temperature cultivator.
4. Absorbent paper.
5. Double distilled water or deionized water.
6. Single or multi–channel pipettes with high precision and disposable tips.
7. Precision pipettes to deliver 2  $\mu$ L to 1 mL volumes.

## Safety Notes

1. This kit is only used for lab research and development and should not be used for human or animals.
2. Reagents should be regarded as hazardous substances and should be handled carefully and correctly.
3. Gloves, lab coats, and goggles should always be worn to avoid skin and eyes coming into contact with Stop Solution and TMB. In case of contact, wash thoroughly with water.

## Test Principle

The test principle applied in this kit is Sandwich enzyme immunoassay. The microtiter plate provided in this kit has been pre-coated with an antibody specific to D-Dimer(D2D). Standards or samples are added to the appropriate microtiter plate wells then with a biotin-conjugated antibody specific to D-Dimer(D2D). Next, Avidin conjugated to Horseradish Peroxidase (HRP) is added to each microplate well and incubated. After TMB substrate solution is added, only those wells that contain D-Dimer(D2D), biotin-conjugated antibody and enzyme-conjugated Avidin will exhibit a change in color. The enzyme-substrate reaction is terminated by the addition of sulphuric acid solution and the color change is measured spectrophotometrically at a wavelength of  $450\text{nm} \pm 11\text{nm}$ . The concentration of D-Dimer(D2D) in the samples is then determined by comparing the OD of the samples to the standard curve.

## Sample Collection and Storage

**Serum** - Samples should be collected into a serum separator tube. After clotting for 2 hours at room temperature or overnight at 4°C, and then centrifuging at 1000 × g for 20 minutes. Assay freshly prepared serum immediately or store samples in aliquot at –20°C or –80°C for later use. Avoid repeated freeze–thaw cycles.

**Plasma** - Collect plasma using EDTA or heparin as an anticoagulant. Centrifuge samples at 1000 × g and 2–8°C for 15 minutes within 30 minutes of collection. Remove plasma and assay immediately or store samples in aliquot at –20°C or –80°C for later use. Avoid repeated freeze–thaw cycles.

**Tissue homogenates** - The preparation of tissue homogenates will vary depending upon tissue type.

1. Rinse the tissues in pre-cooled PBS to completely remove excess blood, and weigh them before homogenization.
2. Mince the tissues to small pieces and homogenized them in fresh lysis buffer (different lysis buffer needs to be chosen based on subcellular location of the target protein) (PBS can be used as the lysis buffer of most tissues) (w:v = 1:9, e.g. 900 µL lysis buffer is added in 100 mg tissue sample) with a glass homogenizer on ice (micro tissue grinders, too).
3. Ultrasound the obtained suspension with an ultrasonic cell disrupter until the solution is clear.
4. Then, centrifuge the homogenates for 5 minutes at 10000 × g and collect the supernatant and assay immediately or store in aliquots at ≤ –20°C.

\*Note: Tissue homogenates are recommended to be tested for protein concentration at the same time to obtain a more accurate concentration of the test substance per mg of protein.

**Cell lysates** - Cells need to be lysed before assaying according to the following directions.

1. Adherent cells should be washed by pre-cooled PBS gently, and then be detached with trypsin, and collect them by centrifugation at 1000 × g for 5 minutes (suspension cells can be collected by centrifugation directly).
2. Wash cells 3 times in pre-cooled PBS.
3. Then, resuspend the cells in fresh lysis buffer with concentration of 10<sup>7</sup> cells/mL. If it is necessary, the cells could be subjected to ultrasonication until the solution is clear.

4. Centrifuge at  $1500 \times g$  for 10 minutes at  $2-8^{\circ}\text{C}$  to remove cellular debris. Assay immediately or store in aliquots at  $\leq -20^{\circ}\text{C}$ .

**Urine** - Collect the first urine of the day (mid-stream) and discharge it directly into a sterile container.

Centrifuge to remove particulate matter, assay immediately or aliquot and store at  $\leq -20^{\circ}\text{C}$ . Avoid repeated freeze-thaw cycles.

**Saliva** - Collect saliva using a collection device or equivalent. Centrifuge samples at  $1000 \times g$  at  $2-8^{\circ}\text{C}$  for 15 minutes. Remove particulates and assay immediately or store samples in aliquot at  $\leq -20^{\circ}\text{C}$ . Avoid repeated freeze-thaw cycles.

**Feces** - Dry feces were collected as much as possible, weighing more than 50 mg. The feces were washed three times with PBS (w:v = 1:9, e.g. 900  $\mu\text{L}$  lysis buffer is added in 100 mg feces), sonicated (or mashed) and centrifuged at  $5000 \times g$  for 10 minutes, where the supernatant was collected for testing.

**Cell culture supernatants and other biological fluids** - Centrifuge samples at  $1000 \times g$  for 20 minutes. Collect the supernatant and assay immediately or store samples in aliquot at  $-20^{\circ}\text{C}$  or  $-80^{\circ}\text{C}$  for later use. Avoid repeated freeze-thaw cycles.

**Cerebrospinal fluid (CSF)** - Remove particulates by centrifugation and assay immediately or aliquot and store samples at  $\leq -20^{\circ}\text{C}$ . Avoid repeated freeze-thaw cycles.

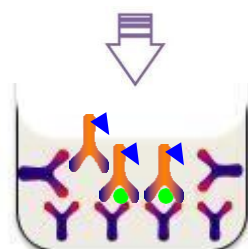
## Notes

1. Samples to be used within 5 days may be stored at  $4^{\circ}\text{C}$ , otherwise samples must be stored at  $-20^{\circ}\text{C}$  ( $\leq 1$  month) or  $-80^{\circ}\text{C}$  ( $\leq 2$  months) to avoid loss of bioactivity and contamination. Avoid repeated freeze-thaw cycles.
2. Sample hemolysis will influence the result, so it should not be used.
3. When performing the assay, bring samples to room temperature.
4. If the concentration of the test material in your sample is higher than that of the Standard product, please make the appropriate multiple dilutions according to the actual situation (it is recommended to do preliminary experiment to determine the dilution ratio).

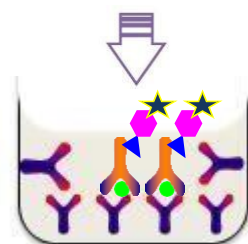
## Summary



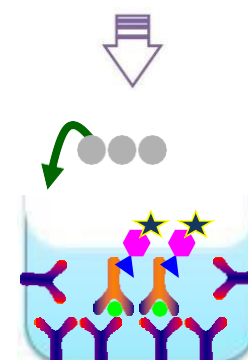
1. After the kit is equilibrated at room temperature, add 100  $\mu$ L of Standard Working Buffer (gradually diluted according to the instructions) or 100  $\mu$ L of sample to each well, and incubate at 37°C for 80 minutes.



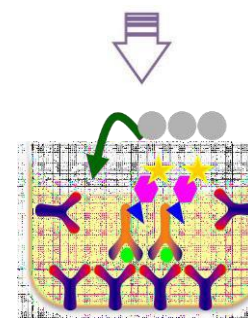
2. Discard the liquid in the plate, add 200  $\mu$ L 1  $\times$  Wash Buffer to each well, and wash the plate 3 times. After spin-drying, add 100  $\mu$ L Biotinylated Antibody Working Solution (1 $\times$ ) to each well, incubate at 37°C for 50 minutes.



3. Discard the liquid in the plate, add 200  $\mu$ L 1  $\times$  Wash Buffer to each well, and wash the plate 3 times. After drying, add 100  $\mu$ L 1 $\times$  Streptavidin-HRP Working Solution to each well, incubate at 37°C for 50 minutes.



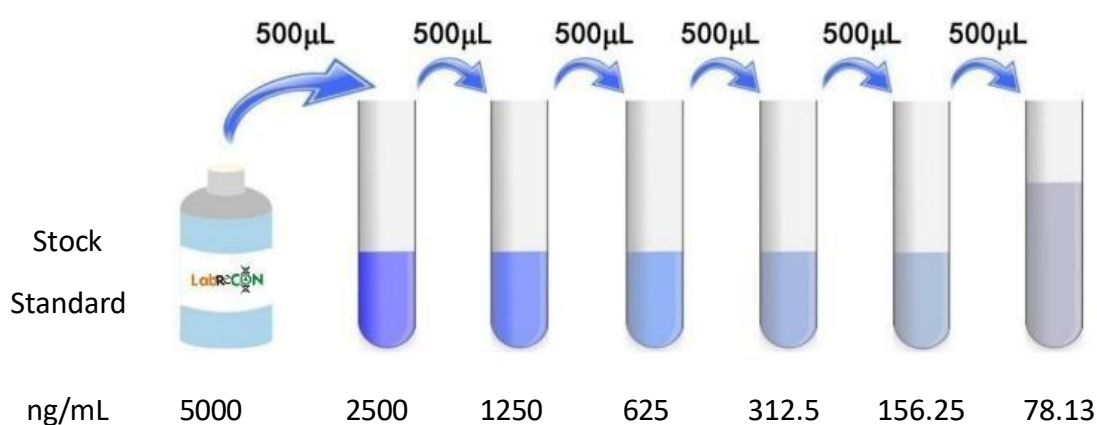
4. Discard the liquid in the plate, add 200  $\mu$ L 1 $\times$  Wash Buffer to each well, and wash the plate 5 times. After spin-drying, add 90  $\mu$ L TMB Substrate Solution to each well, incubate at 37°C for 20 minutes in the dark.



5. Add 50  $\mu$ L Stop Solution to each well, shake plate on a plate shaker for 1 minute to mix. Record the OD at 450 nm immediately, calculation of the results.

## Reagent Preparation

1. Bring all kit components and samples to room temperature (18–25°C) before use.
2. If the kit will not be used up in 1 time, please only take out strips and reagents for present experiment, and save the remaining strips and reagents as specified.
3. Dilute the 25× Wash Buffer into 1× Wash Buffer with double-distilled Water.
4. **Standard Working Solution** - Centrifuge the Standard at 1000 × g for 1 minute. Reconstitute the Standard with 1.0 mL of Standard Diluent Buffer, kept for 10 minutes at room temperature, shake gently (not to foam). The concentration of the Standard in the stock solution is 5000 ng/mL. Please prepare 7 tubes containing 0.5 mL Standard Diluent Buffer and use the Diluted Standard to produce a double dilution series according to the picture shown below. To mix each tube thoroughly before the next transfer, pipette the solution up and down several times. Set up 7 points of Diluted Standard such as 5000 ng/mL, 2500 ng/mL, 1250 ng/mL, 625 ng/mL, 312.5 ng/mL, 156.25 ng/mL, 78.13 ng/mL, and the last EP tubes with Standard Diluent is the Blank as 0 ng/mL. In order to guarantee the experimental results validity, please use the new Standard Solution for each experiment. When diluting the Standard from high concentration to low concentration, replace the pipette tip for each dilution. Note: the last tube is regarded as a Blank and do not pipette solution into it from the former tube.



5. **1 × Biotinylated Antibody and 1 × Streptavidin-HRP** - Briefly spin or centrifuge the stock Biotinylated Antibody and Streptavidin-HRP before use. Dilute them to the working concentration 100-fold with Biotinylated Antibody Diluent and HRP Diluent, respectively.

6. **TMB Substrate Solution** - Aspirate the needed dosage of the solution with sterilized tips and do not dump the residual solution into the vial again.

## Notes

1. After receive the kit, please store the reagents according to the instructions. The plates can be disassembled to single strips. Please use it in batches on demands. It is recommended that the remaining reagents are used within 1 month after the first test.
2. The test tubes, pipette tips and reagents used in the experiment are all disposable and are strictly prohibited from being reused; otherwise the experiment results will be affected. Kit reagents of different batches cannot be mixed (except TMB, Washing Buffer and Stop Reagent).
3. Lyophilized Standards, Biotinylated Antibody, and Streptavidin–HRP are small in volume and may be scattered in various parts of the tube during transportation. Please centrifuge at  $1000 \times g$  for 1 minute before use. Then, carefully pipette 4–5 times to mix the Solution. Please configure the Standard, Biotinylated Antibody and Streptavidin–HRP Working Solution according to the required amount, and use the corresponding Dilution Solution, cannot be mixed used.
4. Bring all reagents to room temperature ( $18\text{--}25^{\circ}\text{C}$ ) before use. If crystals form in the concentrate ( $25 \times$ ), it is a normal phenomenon. Heat it to room temperature (the heating temperature should not exceed  $40^{\circ}\text{C}$ ), gently Mix until crystals are completely dissolved.
5. Prepare to dissolve Standard within 15 minutes before the test. This Standard Working Solution can only be used once. If the dissolved Standard is not used up, please discard it. The sample addition needs to be rapid. Each sample addition should preferably be controlled within 10 minutes. To ensure experimental accuracy, it is recommended to test duplicate wells, and when pipetting reagents, keep a consistent order of additions from 1 well to another, this will ensure the same incubation time for all wells.
6. During the washing process, the residual washing liquid in the reaction well should be patted dry on absorbent paper. Do not put the paper directly into the reaction well to absorb water. Before reading, pay attention to remove the residual liquid and fingerprints at the bottom, so as not to affect the microplate reader reading.



7. TMB Substrate Solution is light-sensitive, avoid prolonged exposure to light. Dispense the TMB Substrate Solution within 15 minutes following the washing of the microtiter plate. In addition, avoid contact between TMB Substrate Solution and metal to prevent color development. TMB is contaminated if it turns blue color before use and should be discarded. TMB is toxic, avoid direct contact with hands.
8. Bacterial or fungal contamination of either samples or reagents or cross-contamination, between reagents may cause erroneous results.

## Samples Preparation

1. Equilibrate all materials and prepared reagents to room temperature prior to use. Prior to use, mix all reagents thoroughly taking care not to create any foam within the vials.
2. The user should calculate the possible amount of the samples used in the whole test. Please reserve sufficient samples in advance.
3. Please predict the concentration before assaying. If values for these are not within the range of the Standard curve, users must determine the optimal sample dilutions for their particular experiments.

## Assay Procedure

1. Determine wells for Diluted Standard, Blank and Sample. Prepare 7 wells for Standard, 1 well for Blank. Add 100  $\mu$ L each of Standard Working Solution (please refer to **Reagent Preparation**), or 100  $\mu$ L of samples into the appropriate wells. Cover with the Plate Cover. Incubate for 80 minutes at 37°C. Note: solutions should be added to the bottom of the micro ELISA plate well, avoid touching the inside wall and causing foaming as much as possible.
2. Pour out the liquid of each well. Aspirate the solution and wash with 200  $\mu$ L of 1  $\times$  Wash Solution to each well and let it sit for 1–2 minutes. Remove the remaining liquid from all wells completely by snapping the plate onto absorbent paper. Totally wash 3 times. After the last wash, remove any remaining Wash Buffer by aspirating or decanting. Invert the plate and blot it against absorbent paper.

Notes: (a) When adding Washing Solution, the pipette tip should not touch the wall of the wells to avoid contamination.

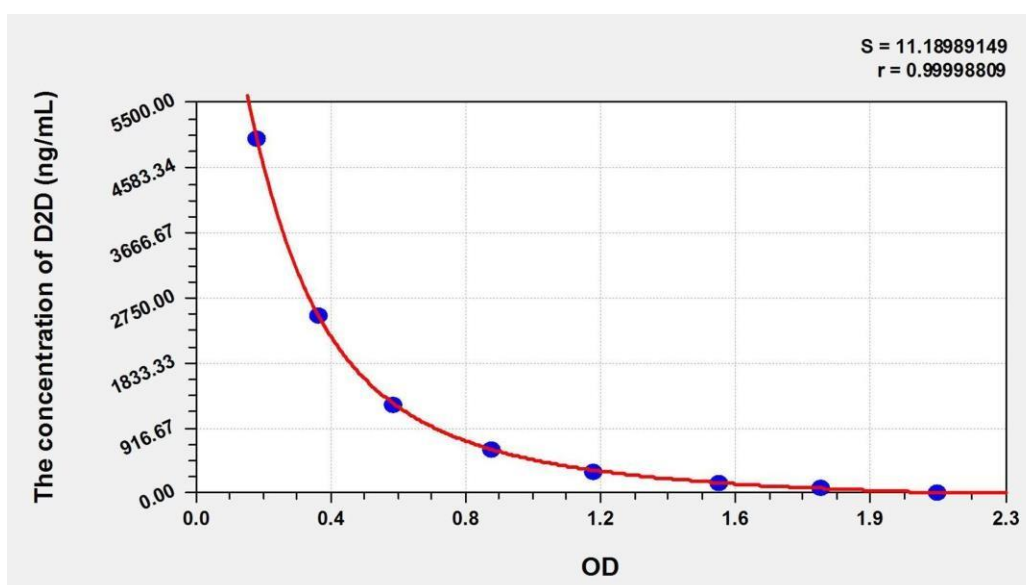
(b) Pay attention to pouring the washing liquid directly to ensure that the washing liquid does not contaminate other wells.

3. Add 100  $\mu$ L of Biotinylated Antibody Working Solution to each well, cover the wells with the Plate Cover and incubate for 50 minutes at 37°C.
4. Repeat the aspiration, wash process for total 3 times as conducted in step 2.
5. Add 100  $\mu$ L of Streptavidin–HRP Working Solution to each well, cover the wells with the plate sealer and incubate for 50 minutes at 37°C.
6. Repeat the aspiration, wash process for total 5 times as conducted in step 2.
7. Add 90  $\mu$ L of TMB Substrate Solution to each well. Cover with a new Plate Cover. Incubate for 20 minutes at 37°C (Don't exceed 30 minutes) in the dark. The liquid will turn blue by the addition of TMB Substrate Solution. Preheat the Microplate Reader for about 15 minutes before OD measurement.
8. Add 50  $\mu$ L of Stop Reagent to each well. The liquid will turn yellow by the addition of Stop Reagent. Mix the liquid by tapping the side of the plate. If color change does not appear uniform, gently tap the plate to ensure thorough mixing. The insertion order of the Stop Reagent should be the same as that of the TMB Substrate Solution.
9. Wipe off any drop of water and fingerprint on the bottom of the plate and confirm there is no bubble on the surface of the liquid. Then, run the microplate reader and conduct measurement at 450 nm immediately.

## Calculation of Results

Average the duplicate readings for each Standard, Control, and Samples and subtract the average zero Standard optical density. Construct a Standard curve with the Human D2D concentration on the y-axis and absorbance on the x-axis, and draw a best fit curve through the points on the graph. If samples have been diluted, the concentration read from the Standard curve must be multiplied by the dilution factor. Using some plot software, for instance, curve expert.

## Precision

Intra-assay Precision (Precision within an assay): **CV% < 8%**

Three samples of known concentration were tested twenty times on 1 plate to assess intra-assay precision.

Inter-assay Precision (precision between assays): **CV% < 10%**

Three samples of known concentration were tested in forty separate assays to assess inter-assay precision.

## Recovery

Matrices listed below were spiked with certain level of recombinant D2D and the recovery rates were calculated by comparing the measured value to the expected amount of D2D in samples.

## Linearity

The linearity of the kit was assayed by testing samples spiked with appropriate concentration of D2D and their serial dilutions. The results were demonstrated by the percentage of calculated concentration to the expected.

## Declaration

1. The kit may not be suitable for special experimental samples where the validity of the experiment itself is uncertain, such as gene knockout experiments.
2. Certain natural or recombinant proteins, including prokaryotic and eukaryotic recombinant proteins, may not be detected because they do not match the detection antibody and capture antibody used in this product.
3. This kit is not compared with similar kits from other manufacturers or products with different methods to detect the same object, so inconsistent test results cannot be ruled out.

## Analysis of Common Problems and Causes of ELISA Experiment

### High background/non-specific staining

	ELISA plate was not washed sufficiently	Make sure that the same amount of Washing Solution is added to each microwell during the washing process. After washing, press the ELISA plate firmly on the absorbent paper to remove the residual buffer.
	Incubation time too long	Please strictly follow the steps of the manual
	Streptavidin–HRP contaminates the tip and TMB container or positive control contaminates the Pre-coated Microplate	When absorbing different reagents, the tips should be replaced. 	Biotinylated Antibody or Streptavidin–HRP concentration too high	Check whether the concentration calculation is correct or use after further dilution.
